Remains which are not to be embalmed shall not be held at the funeral home facility for a period of time in excess of forty eight 48 hours from the time of death or, at the discretion of the funeral director, for such length of time as may be practicable in the interest of health, sanitation and general safety of staff, agents and public at the discretion of the funeral director.		
Note: At the discretion of the funeral director and upon advisement to the purchaser, remains		

which are not to be embalmed and which may require alternate arrangements for shelter or 'holding' until such time as services or disposition may be provided, may be subject to additional cost to the purchaser. Such arrangements may be treated as a required disbursement or as an additional funeral home fee and the fee will be disclosed on contract.

Embalming of Remains: Requires inclusion of Facility for preparation or shelter remains \$ **365.00**

Embalming is the process of replacing blood and bodily fluids with chemical preservatives. It is a process of sanitation, restoration and temporary preservation. Embalming may not be legally required but may be recommended to preserve the body between the time of death and any private or public viewing or visitation or disposition of the deceased. The funeral director will make a recommendation based upon such circumstances including but not limited to the condition of the body and the interval of time for services as may be requested to be provided and such recommendation shall be based on the professional opinion of the director. See *Note* above regarding alternate shelter arrangements. Embalming, including the subtle use of cosmetics, is often recommended when a period of public viewing, visitation and or service is requested. Reconstructive or restorative work may be charged additional to above. Hairdressing by funeral home staff is included in fee for embalming. *Preparation or embalming of infectious cases and reconstructive or restorative work or significant measure may be charged in addition to basic embalming fee as above.*

DISBURSEMENTS

Disbursements are items requested or required in the provision of the funeral services for the Recipient as may be ordered by the funeral home as agent at the request of and on behalf of the Purchaser.

These items may be arranged or procured by the funeral home on behalf of the Purchaser *or many may be secured directly by the Purchaser thus avoiding addition of HST or additional HST.*

Disbursements costs are generally due upon order and/or prior to delivery.

The funeral home may offer to provide payment for disbursements on behalf of the Purchaser if authorized. However, the responsibility for payment remains with the Purchaser whether it be provided directly to the supplier of the disbursement or to the funeral home when acting as "Agent for the Purchaser".

The Purchaser acknowledges that disbursements listed on the funeral service contract represent an estimate only and the actual or reconciled costs will be disclosed with the final statement of account.

The funeral home and the Purchaser acknowledge that the funeral home will be acting as "Agent for the Purchaser" with respect to those disbursements for which payment is extended by the funeral home in accordance with the terms of the authorized agreement and funeral service contract.

Disbursements Required or Requested may include but are not limited to:

- ***Coroner fees:*** Applicable with application for cremation
- ***Inscription work:*** Completion of monument engraving – e.g. date of death
- ***Honoraria*** (e.g. services at church or alternate facility or hall) as requested/directed by Purchaser per Contract
May include: Clergy or celebrant
Organist or musician/choir/soloist/piper
Caretaker or custodian
Sound Technician
Preparation of Bulletins (by other than funeral home – i.e. church)
Church or Hall rental fees
Catering and/or reception facility and/or food and beverage supplies
- ***Notices and /or Announcements***
These are charges for death notifications by print or radio or other media which may include website postings and obituary formats as authorized by the Purchaser.
- ***Floral Tributes*** may be ordered on behalf of the Purchaser and provided by local florist services and, if so, will be generally limited to the acquisition for immediate family member tributes (e.g. spouse, children, grand / great-grandchildren) on behalf of the Purchaser.
- ***Municipal Registration Fee:*** This fee is charged by the municipality at the time of registration of the death. The fee is set by the municipality in which the death is registered and the fee may therefore vary.
- ***Cremation Fees:*** Separate contract may be required. Applicable for at need services only at Innisvale Cemetery and Crematorium or Flesherton Cemetery Crematorium with which Funeral Home maintains sales agency relationship through a signed Sales Representative Agreement to sign cremation application contracts on behalf of crematorium.
- ***Cemetery opening and closing fees:*** Purchaser must contract with cemetery. Funeral Home does not hold a Sales Representative Agreement with either local cemeteries in the Municipality of the Town of Blue Mountains or the Municipality of the Town of Meaford and therefore cannot enter into a contract on behalf of the Purchaser with respect to cemetery matters. Funeral Home may arrange to facilitate purchase of interment rights certificate or permit to open and close a grave for at need services only. As such the funeral home is not responsible for any transactions with the municipalities noted or other municipalities or cemetery operations with which client families or 'Purchaser' may require services. As such, the funeral home cannot extend offer to provide fee for opening and closing as a disbursement through agent status and cannot provide authorization for such.
Such authorization and payment of any and all fees remains the responsibility of the Purchaser services unless so directed by Purchaser..
